[2] Within its broad framework, this novel genre encompasses a wide variety of genres and styles: picaresque, epistolary, Gothic, romantic, realist, historical, and only a few more important ones.[3]

Character analysis is expected to describe the personality of each character through the things they say, feel, and do. It's not as difficult as it seems to find out the personality traits of a character based on his thoughts and behavior.[4] However, this analysis is more focused on identifying the main character of a novel to describe human life and activities in such a way as to display various actions, often in the form of a monologue or dialogue from a character. Human conflict could be analyzed by psychologists or people who can give good suggestions or positive motivation. The typical dispute that arises in humans is from the negative ego.[5]

Six Main Elements in Novels Character Characters are the imaginary people you write about in your fiction or drama—examples of fictional characters are Harry Potter, Oliver Twist, Hamlet, and Cinderella.[12] Plot The plot is what happens in a work of fiction, and the order that happens in for there to be a story, something has to move; to change, something goes from point A to point B (for example, points A and B are two different activities to continue the Setting The setting is where your novel takes place; your setting might be a room, a forest, a battlefield, etc. Setting can create an atmosphere for your fiction, helping your reader imagine the scene.[12] A narrative point of view is the perspective from which you tell Narrative point of view a work of fiction. The contents of the character's conversation in a story that Dialogue. the author uses to describe an ongoing condition in the story.[14]

Dialogue is your characters' conversation presented directly on the page. [15], [16] The daily life of the characters in the story always influences the novel's events. According to Aminuddin, performers who carry events in fiction that the event can establish an account of are called characters.[17], [18]

Characters in fiction can be humans or others who give them human behaviour, such as animals, a thing, or a plant. According to M. Atar Semi, there are two ways to introduce the character and his personality in fiction. These are analytic and dramatic:

Analytic: the author said directly the character's personality in fiction. Dramatic: the author describes the character's personality indirectly, but it is told through kinds of character names, describing the character physically and through dialogue. There are some kinds of characters types in literature work:

Table 2. Types of Characters in Literary Works		
Flat Character	A flat character has one or two personality traits that don't change. The flat character can play a major or a minor role.[19]	
Round Character	A round character has many complex traits that develop and change in a story. A rounded character will seem more accurate than a flat character because people are complex!	
Stock or Stereotype Character	A character representing a stereotype is a stock character. These characters exist to maintain widespread belief in "types," such as hot-tempered redheads, stingy businessmen, and absent-minded professors.[20]	
Static	A static character never changes. A loud, obnoxious "background" character who remains the same throughout the story is static. A bland character that is never changed by events is also static. [21]	
Dynamic	Unlike a static character, a dynamic character changes and grows as the story unfolds. Dynamic characters respond to events and experience a change in attitude or outlook.[22]	

An individual's character is that person's collection of character traits, and these can be defined as relatively stable dispositions to think, feel, and behave in specific ways in certain situations. Two classic examples are bravery and cowardice, the dispositions to think, feel, and behave bravely in the face of actual or apparent danger. The language used to characterize the patterns in a person's thoughts, feelings, and behaviour need not always refer to character traits since some might refer to the absence of traits. An inconsiderate person, for example, might best be described as one who lacks consideration for others, one whose behaviour noticeably lacks such consideration, rather than one who has the trait of behaving inconsiderately.

METHOD

This research is library research, data obtained from a novel. [23], [24], [25] This is library research, the data obtained from a novel entitled "Cover of Night" by Linda Howard. The researcher will describe the novel's main character in terms of psychological aspects. This novel contains essential information about character and characterization, so the significance of the research is to examine psychological aspects related to character types in literary works, namely, character flats, Round characters, Stock of Stereotype characters, and Static and dynamic characters. In this first step, the researcher reads the novel carefully so that I understand it without confusing the meaning of words that are hard to see. When reading a novel, the researcher collects and underlines essential points, such as information about the main character's characteristics. The same is done from books and related references by marking information parallel to novels. Data analysis techniques are carried out by collecting primary data and tabulating it, analyzing several dialogues that refer to the object of study character values, and then interpreting and explaining them. [26], [27], [28] In the final section, the author interprets and analyzes using concepts related to literature and character analysis.

RESULT AND DISCUSSION

The writer used a descriptive qualitative method to describe the result of the data in this research. [29], [30] The approach the writer used to analyze the main character in this novel is Psychological Approach. Psychological analysis is used to get a clear description of the actions done by the characters in the story, in this case, a Novel, based on psychology theories.

In this novel, the writer reads the novel several times until the writer finds who was the main character in this novel. The writer classified the character into main characters and supporting characters. The main character was the main actor that played an essential role in the story. The supporting characters supported the main characters in building a story.

There are several steps the writer did in analyzing the main characters in Cover of Night novel. The steps are 1. The writer intensively reads the novel Cover of Night by Linda Howard, 2. Determine the dialogue directly and indirectly stated in the novel, and 3. The writer classified and analyzed the main characters in Cover of Night based on the psychological analysis theory.

1. A Brief Description of Cover of Night Novel by Linda Howard

The novel Cover of Night by Linda Howard represents a story that often occurs in society. The theme is love and sacrifice. The story begins with the situation in B&B (Bed & Breakfast) when Cate Nightingale served her customers. Cate is the owner of B&B located in Trail Stop, Idaho. People in Idaho realized that Cate was beautiful and charming with her proportional body, which attracted the man's eyes to look at her. The conflict in this novel began when Jeffrey Layton, one of Cate's customers, left the room mysteriously. Mr Layton left his stuff, such as bath tools, shoes, and clothes. It made Cate confused because Mr Layton did not say anything before, he left B&B, but he left his credit card number so Cate could take money for the room payment.

Mr Layton was A CPA (Certified Public Accountant) in Bandini's Company. Mr Layton had been the most wanted man; even Bandini had hired a professional private investigator, Youell Faulkner, to find Mr Layton.

The story's climax in Cover of Night's novel happened when bad guys fired some places in Trail Stop and blew the bridge. People in Trail Stop were bleeding, and some of them died. Trail Stop was full of a strained situation, and people, including Cate, were

terrified. In this situation, Calvin Harris became the hero; he saved people by directing them to find a safe place to protect themselves. As the ex-climber, Cate quickly climbed the hill, so the riflemen could not see her, and Cal helped her.

Cate and Calvin Harris finally fell in love with each other after the incident. Cate was impressed with Cal's bravery in saving people from the rifle fire. Cal also shows his careness for Cate because he loved Cate from the first, he looked Cate for the first time. Cate knew Calvin Harris as a handyman, but then she knew that Calvin Harris was a marine. In this novel, Linda Howard, as the author, presented a story that showed the power of love, sacrifices, faithfulness, careness.

2. The Psychological Analysis of the Main Character in Novel

After reading the novel and understanding the story, the writer found that there were two main characters in this novel. They were Cate Nightingale and Calvin Harris. Both characters were enjoyable to be analyzed because the characters represented the good side of humans, such as loving and helping each other. Cate and Calvin also sacrificed themselves to save people in Trail Stop, Idaho, from the offence of riflemen.

a. The Psychological Analysis of Cate Nightingale's Character

Cate Nightingale is one of the main characters in Cover of Night Novel. She was a 29 widower who had two twin sons. In the first analysis, the writer described the physical dimension of Cate Nightingale.

"Her eyes were still brown, a lighter, more golden shade of brown than her hair, but...brown. Unexciting brown. And her body was still the same shape it had always been, except during her pregnancy, when she'd had full breasts. In this description, Cate is described as a plain woman, but her sex appeal is so prominent. Some visitors, mostly men, are attracted to Cate's physical appearance. Even though she did not like to use cosmetics, she was still attractive and charming.

The author also described Cate as a faithful woman. Her husband had died when they had their time for only seven years. She lived with her twin sons, Tucker and Tanner, far away from her family. Even though many men liked her, including Calvin Harris, Cate never showed her willingness to accept another man because she loved her husband so badly.

"Creed was even worse than Cal; at least Cal had a reason for waiting because cate had still been shell-shocked from losing her hushand. Three years was a long time to wait, but grief took its own sweet time; even after she had recovered from that and could laugh again, she had protected herself by building a wall between her and any eligible man."

Cate was a rock climber, and she met her husband, Derek, when they joined the climber club and often climbed together. Derek died because of the wound infection on his foot. Cate then preferred to move to Idaho with her lovely twin sons.

Cate chose to move to Idaho because Idaho has a lower cost of living. Idaho is remote and rural, and Cate's mother disagreed when cate and her sons had to move to an area like Idaho. But Cate considered her financial situation. Cate was a hardworking woman who felt she had a big responsibility to her sons. She loved her sons and cared for them until they were adults.

"But she hadn't, so she'd done what she'd thought was best for the twins. When Derek died, leaving her with her nine-month-old twins, not only had she been devastated by losing him, but she had also been forced to face the reality of their finances. Their combined incomes had provided a good living, but Cate had gone to part-time when the boys were born, and most of her work she's done from home. With Derek gone, she had to work full-time, but the cost of quality daycare for the boys had been prohibited."

The writer analyzed the personalities of the main characters based on the theory of personality that nature refers to 'stable, internal factors that make one person's behaviour consistent from one time to another; and different from the behaviour other people would manifest in comparable situations

Cate Nightingales characters consistent personality showed she stayed faithful to her husband. She loved her husband so much. Even though many guys were interested in Cate, she was never seduced to have a serious relationship. At the end of the story, Cate finally falls in love with Calvin and plans to get married, but she never deletes her husband's name from her heart. She had two cute sons in her marriage with Derek, which means that Derek was still the son's father, and no one could change it.

The same consistent personality was also shown by Calvin Harris, the man who had loved Cate since he met Cate for the first time. Calvin waited for Cate to change her mind about accepting him for about three years. He helped Cate every time cate needed his help. He waited for about three years until Cate finally decided to marry him. Three times was not a short time, but Calvin patiently waited.

The character of Cate and Calvin were described by the author differently from the other characters. Cate was diligent, strong, powerful, and had a lovely heart. This character differed from other female characters like Neenah, Maureen, and Sherry. It also happened to Calvin Harris. The heroic personality of Calvin was different from that of her Marine friend, Joshua Creed, whereas they were together marine. Calvin sacrificed himself when the riflemen shooted Idaho and injured many people there. Calvin also showed his clever mind in the strategy of avoiding the riflemen's shoots.

Cate and Calvin fell in love with each other but did not show their feelings because they may not recognize each other yet.
